ORDER OF BUSINESS

Chairperson: Annette D. - Opened the meeting with the Serenity Prayer. Let the record show that the Assembly was brought to order at 9:00 a.m. on Sunday January 15, 2017.

Registrar: Stephen R. - We have 181 voting members in attendance this morning with two-thirds being 121.

Reading of Anonymity Statement and short form of the 12 Concepts.

OFFICER REPORTS

Secretary: Lori P. – My name is Lori P. , it is my privilege to serve as your Secretary for Panel 67. Minutes forwarded from the Panel 65 secretary to the Registrar in a timely manner. I met with past Secretary Annette D. after the Officers Interim Meeting held in Gainesville in December. All materials and laptop were passed forward to me. Envelopes were printed for mailing of the minutes via U.S. Postal Service at a cost of \$300.00 for 1,000 envelopes. There will be one correction to the October minutes; Roll Call this morning was done by Stephen R. our new Registrar instead of Richard C. as noted on the Agenda of the Minutes. I have received no other corrections to the Minutes for October; are there any other corrections at this time? Thank you for the opportunity to serve. Chair entertained a motion to accept minutes, motion made, seconded and passed unanimously.

Treasurer Report: Terri-Lynn S. – I am an alcoholic and my name is Terri-Lynne S; I am privileged to serve as your NFAC Treasurer. The Financial Statements on the table is our Annual Report for 2016. Let’s start with the top form, the Balance Sheet. We currently have \$85,316.15 labeled Total Checking/Savings which combines three separate accounts: Sun Trust checking at \$15,031.33, Sun Trust money market at \$40,016.68 and Sun Trust CD at \$30,268.14 that will mature 12-6-2018. The pre-paid expense account of \$1,749.43 represents expenses incurred by Panel 67 members before the end of 2016. We do not want members to have to wait to be reimbursed but at the same time we must show the expenses in the correct year and correct budget. The inventory of \$1,480.26 is our Grapevine store retail and Grapevine Subscriptions that we had on hand after the October Assembly. Moving on to the next page, titled Assembly P & L Actual. vs. Budget report, you will see contributions of \$47,143.11 are slightly higher than projected. Historically contributions do pick up in the 4th quarter. We also received outside contributions from other A.A. entities in the amount of \$5,595.80. Our annual expenses shown on page 4, labeled Total Expenses of \$45,858.80 were much less than our 2016 budget at \$60,295.00. Our year ended with net income in excess of expenses in the amount of \$12,489.47. The detailed Group Contribution Summary Report is next and shows total contributions of \$47,143.11 on page 7. Referring to the last page titled Prudent Reserve and Financial Summary: This is the time of the year that the Treasurer Reports to the Fellowship where we stand on our Prudent Reserve. In

summary, this page shows how the Prudent Reserve is calculated and at this time the NFAC is over Prudent Reserve by \$35,762.00. According to our Structures and Guidelines the Finance Committee will be addressing the Prudent Reserve at the April Administrative Committee meeting. Thank you.

Southeast Regional Trustee – Chet P. (from the tape) -

Chet provided a brief Overview of the Trustees Board Weekend as of the last weekend in October 2016. Chet currently serves on 3 Trustee Committees; Chairing the Trustees Nominating Committee, Serving on Trustees' Committee on Archives and Corrections. The Trustees Board Weekend provided a unique experience as the previous week the World Service Meeting was held. A good number of World Service Delegates were still on hand and participated in some of the Sharing Sessions. During that weekend, Chet was able to have breakfast with the German Delegate who spoke of the founding of the German Conference; and how 2 years later they founded their own Board of Directors along with the trials and errors they went with perhaps what we take for granted that Bill W. gave us as part of his legacy in the mid 1960's. Chet then provided an Overview of the Quarterly Report from the General Service Office, some information of which is slightly dated as the information is based on the October 2016 Report but do show a trend. Based on the report coming from A.A.WS, the Public Service Announcement "Doors" has aired over 80,000 times in the U.S. and Canada in the last 12 months with 588,000,000 audience impressions. The French and Spanish versions of this PSA will start to air this month. Through September 30th, gross sales are roughly \$59,000. ahead of budget, with eBook sales 43,000 units. The Hebrew, Polish and Thai translation of our Big Book are continuing with the Navajo translation in its final stages of completion. Online sales make up almost 60% of all A.A.WS sales. Financial, at the end of 9 months revenue reported are almost \$800,000 greater than budgeted; and operating expenses are almost \$700,000. under budget. Chet will receive the final reports at the next Board Weekend in two weeks.

Grapevine reported their challenge of carrying the message. Their focus is on subscription sales to maintain self-support of the *Grapevine* and *La Vina*. Over the last 5 years *Grapevine* subscriptions have been declining at about 5 % a year. As of this last Quarter the decline in subscriptions has leveled off. The Senior Editor reported web traffic for the *Grapevine* Website at 41,000 unique visitors and 192,000 page views. *La Vina's*

Circulation is roughly 100 less than last year with a total of 10,415 subscribers.

Archives Committee agreed to forward proposal to the Conference Committee for a new book *Unity in Action, Bill W.'s General Service Talks 1951-1970* (working title) for consideration. The Conference Committee agreed to forward the final report from the subcommittee on electronic voting at Conference to the 2017 Conference Committee on Policy/Admissions with the recommendation that the Conference move ahead to use electronic voting for all Conference voting with the exception of elections for Regional Trustees and Trustees-At-Large, which are conducted by ballot. Cooperation with the Profession Community/Treatment and Accessibilities agreed to forward to the 2017 Conference Committee a recommendation that a LinkedIn page be developed for C.P.C. committees. They also agreed to forward to the Treatment and Accessibilities the revised and retitled draft of "A.A. for the Alcoholic with Special Needs" to the 2017 Conference Committee on Treatment and Accessibilities for approval; accepted the draft revision of the service piece "Serving Alcoholics With Special Needs"; and accepted the new "Accessibilities Checklist". Correction Committee reports progress made with the Canadian government agency, Corrections Canada, in support of A.A.'s Corrections Correspondence Service in the Canadian federal corrections system. The new video "A New Freedom" has been viewed online 470,000 times since it became available in July of 2016. Additional consideration is being given for an abbreviated version of the video being developed for a public service announcement. Finance, the

news is good through Q3 with a 13% increase in the Seventh Tradition Contributions. Traditionally contributions have been rising at about 2% a year which is concerning as costs have been raising at about 3% a year. There was a 2% increase in Literature profits and a 7% decrease in employee costs (due to retiring employee positions not being re-filled/re-placed). There was a 4% decrease in other Operating Expenses. There was an approximate \$900,000.00 profit projected over projected budget for last year. Of the 13% increase in contributions, this can be attributed to 1250 new groups contributing. The so-so news is that group contributions has remained flat at about \$200.00 per group. Much of the increase was due to individual and on-line contributions. The number of people now using the recurring on-line contribution is about 500. This may be attributed to the fact that people may not be aware that they can go to aa.org and sign up for the recurring contribution on-line. As of the end of September the reserve fund had roughly \$15 million is earning about 1% which constitutes about 9.8 months of expenses. The Finance Committee also heard a report from a Sub Committee on Convention Accounting and Funding and will make no changes to current practices. International; The committee noted that the General Services Offices is continuing to work on developing a workable process to deliver A.A. literature to Cuba. In the past literature has been delivered to Cuba through Mexico. The 24th World Service Meeting was held in Rye Brook, New York there were 60 Delegates from 41 countries or zones attending. We are in the pioneering phase of developing A.A. globally. International Conventions and Regional Forums: A report was heard from Greg T. for the 2020 International Convention in Detroit. The Committee recommended and the Board accepted that an “Opt In” box be added to the 2020 International Convention Registration for members who would like to receive additional communication from either A.A. *Grapevine* or A.A. World Services. In Literature, the Committee agreed to forward to the Publishing department the following with respect to revision “ A.A. for the Woman”, “A.A. and the Gay/Lesbian Alcoholic” and development of literature for alcoholics with mental health issues. Finally, the Committee agreed to forward to the 2017 Conference Committee the draft language informing members about young people’s conferences, and to the 2017 Conference Committee on Report and Charter a request to add a footnote on Concept VIII. Nominating: The Committee recommended and the Board approved that Elaine McDowell be reinstated as trustee emerita on the General Service Board. Ms. McDowell was a Class A Trustee who resigned due to family matters. Because she had resigned, and this being a voluntary position, Ms. McDowell was reinstated and approved. The Nominating Committee was very involved in the nomination process of the new Board and there were 3 candidates vetted; and Michelle Grinburg will be put forward as the upcoming Chair of the General Service Board. Public Information: the Sub Committee reviewed the timing of the Membership Survey and agreed that it will be conducted this year just as it was last year. They are also gathering information on the possibility of future surveys being conducted on-line. Currently, these are done by pencil and paper. The general concern of a potential on-line survey would be the statistical accuracy of the survey in terms of representing the Fellowship as a whole. Looking forward, the first weekend in February there will be a Delegate’s Get Together in Atlanta where Joyce and Heather will attend from our Area. The Get Together although it may sound like a social event is an event designed to prepare the incoming Delegate and their Alternate to attend their first Conference. It is also designed so that the Regional Trustee delivers the year-end report. Thanking us for the opportunity to serve, Chet’s path to Southeast Regional Trustee started in Area 14 and as of this report now ends here.

Delegate Report: Joyce C. – Good Morning everyone, my name is Joyce C. and I am honored and privileged to be serving as your Delegate to the General Service Conference. I am humbled by your trust in me. Who knew when I walked into my first A.A. meeting, dirty and disheveled that I would be your

voice to the General Service Conference. When I got here, I was told I would be happy, joyous and free. I had no idea that I would have days as joyful as yesterday and I thank you for that.

First, I wish to recognize and thank our Past Delegates for their service: Panel 45 - Dan E., Panel 51-Tom G., Panel 53 – Corliss G., Panel 55 – Michael S., Panel 57 – Fred H., Panel 59 – Chet P.- Southeast Regional Trustee, Panel 63 – Marilyn B., and for the first time as Past Delegate, Panel 65 – Glenn W. Thank you all for your service. The work of Area 14 has been going on non-stop since our election assembly in October, your Chair and I have worked very closely discussing several topics, including planning an interim Officers meeting to prepare new panel members for their jobs. We also are working to revitalize non-represented Districts. Last November, I received a welcome letter from our General Service Office accompanied by information helpful to the new Delegate. The theme for the 67th Conference is "Supporting Our Future". During the Conference there will be presentations or discussion topics: Growth, Participation and Contributions. These might be good topics for you to use in your workshops. Late in December, I received correspondence informing me that I was assigned to the Literature Conference Committee. This will keep me very busy at conference I'm sure. I was warned by a Past Delegate that my working day just went from 12 hours a day to 16 hours, we'll see if that holds true. I am excited and ready to take on that challenge. Of course, I will need your help to get ready for Conference. Around February 14th we will receive the Final Agenda Items and Background material. We will distribute these electronically. However, if you require a CD, please let me know. Remember that the background material is not anonymity protected; it is for A.A. members only. I am eager to begin the round of pre-conference workshops around North Florida. I truly believe that the disseminating of the information in this way gives us a significantly greater informed Group Conscience for me to take to the Conference in April. In December, I attended the Southeast Regional Forum chaired by our own Chet P. Area 14 hosted this event. In appreciation of Area 14 hosting this event, the General Service Office generously left us a large amount of literature not taken during the weekend. 434 attended, of those 214 were first timers attending a Regional Forum. There were many Trustees in attendance; 2 Class As, 1 past Class A, 3 Regional Class Bs, and 5 past Class Bs, 10 staff members from the General Service Office and many Southeast Regional Delegates. Of the \$1,000.00 contributed by Area 14 for coffee \$988.20 was spent to furnish 18 gallons of coffee. Over 60 volunteers worked as greeters, registration, signs, setup and takedown. Thank you to everyone participating, especially Past Delegate Cecilia R. organized the host committee. The presentations and sharing sessions were focused on many different topics. The Forum report will be out in a few months. If you would like a copy, please contact me at delegate@A.A.northflorida.org. The next time the Forum comes to North Florida won't be until 2024! So, if you missed this one, mark your calendars, the next will be in Sterling, VA November 16-18, 2018 at the Washington Dulles Airport Marriott Hotel. On to Area events, I was invited to participate in a GSR Workshop in District 11 on December 10th - Incoming DCM, Deb along with members Daryl, Marcela and Ray did a great job pulling this informative workshop together. I facilitated a "mock" Area Assembly including the "making a motion" process. This was a great service workshop for new GSRs and for anyone interested in General Service. The Southeast Regional Delegate's Get Together will be held February 3-5 in Atlanta. I will be attending with our Alternate Delegate and several Past Delegates. This is always a very informative and sharing event, where I will be assigned a Conference "buddy". I already have one from California assigned by GSO. The 4th Southern States Alcoholics Anonymous Service Assembly (SSA.A.SA) will take place November 10-12 in Atlanta. The flyer is posted on our Area website. Yesterday I co-facilitated the Service Sponsorship workshop with Annette and many helpers, including Dan E., Past Trustee. Thank you Dan for your help. As I said, "Supporting Our Future" is the Theme for the 67th General Service Conference, 2017. At A.A.'s 25th Anniversary Bill Wilson asked this question: "... Where do we go from here and what is our

responsibility for today and for tomorrow ...Will we continue to search out the ever-present flaws and gaps in our communications?...Will we resolutely address ourselves to those many tasks of repair and improvement which even now the future is calling upon us to undertake? Still clearer vision and an ever-mounting sense of responsibility can be the only answers to these questions." As we seek new ways of communications to reach the still suffering alcoholic wherever they may be we must always be aware that the future is now in our hands. Each of you is part of that channel as I pass information to the DCMs who pass the information to the GSRs who pass the information to the groups, I hope that with your help we will inform the groups everything they need to support all of A.A.. The telephone was significant in the beginning of A.A., Ebby phoned Bill W., then, in the Mayflower Hotel Lobby Bill used the telephone to locate another drunk to work with. Today, smart phones, email and the Internet top the list of preferred communication methods society seems to have accepted, if not embraced the increased role technology plays in everyday life. So, how are we "Passing the Message"? Are we reaching the still sick and suffering? Let us use every means of communications possible within our Traditions! I plan to use the Delegate's Corner on our website whenever I have information I think you will be interested in. The first one posted on January 1st. I am available by phone, email, text and I am attempting Twitter, so follow me if you like at [delegate_a14p67](#). If you try to contact me and don't receive a response within 24 hours, please use an alternative method to let me know. Again, Pre-conference workshops will be offered to any Districts who request them. It would be helpful if they are combined with other Districts in their Area. I am not sure what the format will be until I see the agenda items, but my calendar is open for you. If you request a workshop, I will pencil it in, and confirm when I get a flyer for the event. Thank you for trusting me to be your voice at the General Service Conference.

I look forward to accompanying our Delegate in February as we attend the Delegates Get-Together in Atlanta, GA. Thank you for the honor of serving Alcoholics Anonymous..

62nd Florida State Convention Report – Presented by proxy; Ruth B.: Good morning everyone. I'm an alcoholic a member of the Tamarac Group my name is Gary L. My sobriety date is November 9th 1997. I'd like to wish you all a very Happy Sober New Year!!! Great to be back here with you guys and representing District 9 in hosting the 2018 Florida State Convention at the beautiful Fort Lauderdale Marriott Harbor Beach Resort and Spa. Thank you Guidance and District 9 for your support here today. The dates of our Convention are August 15th – 19th, 2018. Pre-registration is \$35.00, on site is \$40.00. We are hopeful to bring up the amount of pre registrations by doing this. Jayme, Treasurer for our Convention and I met with the Marriott on August 25th 2016 and the contract has been signed. We gave the Marriott a \$2,000.00 deposit with a balance of \$5,000.00 due December 2017.

After sending out our Taper request form, we received 3 responses back and after much review have decided to go with Vision Audio. They have thankfully accepted so we have our Taper for the Convention. Our Co Chair for the Convention, Karen V. is in the process of working with Vision Audio to iron out the details of our agreement with PSAV. Finishing the discussion with the Accessibility Checklist, that in 2016 was included in the Special Needs/Accessibilities Kit. Discussion ensued on how Districts and Groups can use the checklist to inventory their accessibility to all alcoholics and if our meetings are not accessible to all maybe it is time to "MOVE YOUR SPACE". Cooperation W/Professional Community Report: Mark A. - Good Morning, my name is Mark A., and I am an alcoholic. I am grateful to serve as your North Florida Area 14 Cooperation with the Professional Community Service Coordinator. We had 34 people in attendance at our workshop this morning, with representation from 18 Districts. We began the workshop with an introduction of the mission of CPC service work, outlined how our 12 traditions apply to working with Professionals, and identified the wide variety of Professionals who can be informed about the fellowship of Alcoholics Anonymous. Next, Alternate CPC Service Coordinator, Dr. Larry, presented his own experience, strength, and hope with his introduction to the fellowship of Alcoholics Anonymous, and the work done to establish a successful CPC committee. Several suggestions of how create and effectively sustain a CPC committee were exchanged, to include being goal oriented; to set time limits to accomplish those goals; and to be well-informed about what A.A. is, and what it is not. We also discussed from experience how to best speak to Professionals and their support staff, and to avoid speaking in a manner which they may infer as directed toward themselves. Furthermore, attendees were exposed to the breadth of A.A. literature that can be used as a resource to leave behind after personal contact with

professionals, as well as the importance of a follow-up after the initial meeting. It was very informative and we thank Marty very much. We look forward to working together in the future.

I then had a friend in A.A. share her story of bringing A.A. meeting into jails for over 12 years. She not only shared her knowledge and successes but also addressed how rewarding this work is. Discussion then took place over the many different rules and protocol one must go through to be allowed into correctional facilities. The Workshop ended with discussion of A.A. pamphlets dealing with subjects such as pre-release contact and corresponding with those inside.

Cooperation with Intergroup Report: Paula D. – Good morning everyone. I am an alcoholic and my name is Paula D. It is truly a pleasure and privilege to serve North Florida Area 14 as the Intergroup Service Coordinator for Panel 67. Our new Alternate Intergroup Service Coordinator is Judy G. of District 31. She joins us with a variety of experiences of services pertaining to Intergroup. We will be working together to carry the message throughout Panel 67 to benefit Area 14, and the Districts. I would like to thank Steve N. of District 28 for taking notes during our workshop yesterday. We had 20 attendees at our workshop; representing eight Districts, five of the participants were Intergroup Representatives, Chairs or Office Managers of Central Offices. They brought a continuum of experiences with Intergroup Service commitments. We had a great deal of information brought forward and experiences shared. Discussions of the workshop included: We reviewed the "A.A. Guidelines for Central or Intergroup Offices" (which are found on the A.A..org website). We identified the autonomy of how each Intergroup / Central Office operates supporting the Traditions of Alcoholics Anonymous. "A.A. Intergroup" is also located on the A.A..org website which has topics and suggestions for Intergroup. Where in the world is Intergroup in the A.A. Service Structure! While Intergroup is part of A.A. as a whole, it is not included within the A.A. Service Structure. It provides supporting services to the A.A. entities.

What is Intergroup and what its role is in A.A.?, "Sharing common problems and solutions" – The common theme was "It takes volunteers to make it work" and how do we attract individuals willing to serve. Some solutions presented included: Some Intergroups breakdown commitments into shorter timeframes and smaller tasks to increase the attract individuals who may have limited time available to serve, Ask! Ask! Ask for help – let the fellowship know what we need help with regarding service needs! Flyers! Announce needs at every meeting. Post needs on your website and in newsletters! Sponsors encouraging sponceses to volunteer.

How do the different Intergroups function in cooperation with Districts and A.A. as a whole? The most important thing is the telephone hotline. Our "voice of attraction". Intergroup is often the first line of contact with the general population via the hotline and the Meeting lists. Intergroups often publish newsletters, and provides literature to their District (s) or Groups. Some of the benefits of Intergroup: Can be a "safe" place for people to go, Hotline, communication link for events. We also discussed potential topics of interest for our upcoming workshops for the Panel. Some of these ideas included: More information about Carrying the Hotline and going on 12 Step calls. Services the Intergroup provides to A.A. as a whole: Treatment, Literature, Grapevine, Accessibilities, Corrections, Cooperation with the Professional Community, Public Information, Districts, and Groups. Selling A.A. Approved Literature and/or carrying literature which has not been approved by A.A.

Family Unity – since A.A. brought them back together. Understanding World Service Please feel free to contact me! I welcome the opportunity to be of service to your District and local Intergroup. Grapevine/La Vina Report: Deb B. – *Grapevine/La Vina*: Deb B. - Good morning. My name is Deb B.; and I am an alcoholic. I would like to thank the Chairperson for appointing me to serve as the Area 14, Panel 67, *Grapevine/La Vina* Service Coordinator. I would like to start by introducing your new alternate Grapevine/LaVina Service Coordinator, Toree D. from District 4. Thank you District 3 for doing an awesome job hosting the bookstore and selling raffle tickets! The money collected helps to maintain a sufficient and diverse inventory on hand. We vended \$247, including sales tax, in the bookstore and \$215 in raffle tickets for a total collection of \$262. Last night, we had the pleasure of giving away seven *Grapevine* subscriptions, congratulations to all of the winners and thanks to everyone for your support. We had a fantastic and informative workshop covering the difference between A.A. literature and *Grapevine* literature. We also discussed "conference approved" literature and the fact that just because something is not conference approved does not mean the conference disapproves of the publication. Furthermore, we discussed reprinting copyrighted material and citing the correct publishing house; for example, when printing the A.A. preamble, cite the phrase: "Reprinted with permission of A.A. *Grapevine*, Inc." *Grapevine* literature is amassed into many different books including Language of the Heart, Best of Bill W., Emotional Sobriety, and the newest book, Our Twelve Traditions. One can order these books in print, multiple electronic formats, or cd. We covered copious facets of the website and then many of us wrote or recorded and submitted our story to the *Grapevine* magazine. Twenty-seven members attended and Toree D. from District 4 took the minutes. Thank you to Area 14 for giving us this opportunity to serve you. Thank you to Paula D. for an awesome turnover from Panel 65 and to Peter C. for continuing on the work as the DCM for District 4. The presentation is available in PowerPoint or Keynote format for anyone who would like a copy. Additionally, we are available to give workshops to your Districts. Please give us a call.

Literature Report: Marcela W. - We discussed definitions of Conference approved literature including duties of Literature Committees at the group, District and Area level Literature services provided by the General Service Office. Public Information Report: Clark M. – Hello, my name is Clark and I am an alcoholic. I am also privileged to serve as your Area 14 Public Information Service Coordinator for Panel 67. Our workshop was conducted yesterday and 32 were in attendance. The history and purpose of Public Information in Alcohol Anonymous was presented. Each attendee received a copy of the A.A. Guidelines for Public Information, suggested goals of Public Information service and a suggested literature list. The Public Information Kit, as prepared by the General Service Office, was made available for review. The Strategic Plan, adopted by the General Service Board in February of 2016, was discussed. Those goals related to Public Information were presented to the attendees. The results of the 2016 General Service Conference related to Public Information were presented, along with actions anticipated for the 2017 Conference. Thank you to my alternate Public Information Chair, David A., for presenting a very informative session on how to establish a Public Information committee in the Districts. He shared on what District 14 is doing and how his committee operates. A main goal of mine is to establish a Public Information Chair in each District, and to have a corresponding committee make suggestions and implement ideas into their community. We ended the workshop with a sharing session among the attendees. A lot of great ideas were presented that members can consider in their Public Information service work. David and I look forward to visiting the Districts to provide workshops or any other type of assistance to assist in expanding the outreach of Public Information throughout Area 14.

Treatment Report: Marty C. - Good morning family. We had a very productive 1st Workshop. There were 30 A.A.'s in attendance, in which 9 agreed to serve on the Area 14 Treatment Committee. That gives us a committee of 11 to start Panel 67. Peter C. (Alt. Treatment Service Coordinator) and I set 3 goals for our first Workshop. In order to be of service to the Treatment Facilities in the Districts of Area 14, we felt that our 1st priority should be to identify and locate them and see which Districts they fell in. We put together a large 3 x 5' map of Area 14 with District boundaries. We had color coded stick pins to identify the locations of In-patient Treatment Center, Out-patient Treatment centers, Detox Center, and Halfway Houses. As we identify locations, we also have them listed with their addresses. We asked our workshop attendees to come up and place pins where they know of Treatment Facilities in their Districts. We will continue to do this at each Assembly Workshop. Peter and I will be doing research to add to the map between Assemblies. Our second goal was to introduce a "Bridging The Gap" Program. We explained the pamphlet forms for the patients and A.A. Volunteers. We will be ordering a stock pile of these forms to have on hand. BTG Programs are typically handled by Intergroups and/or Central Offices. We are going to attempt to implement our Bridging The Gap Program on a District level via Treatment/BTG Workshops. Peter and I plan to blanket Area 14 and provide Treatment Workshops for all of our 33 Districts during our

rotation in Panel 67. Our third goal was to get some feedback and participation from the workshop attendees. We talked about types of treatment facilities including VA Hospitals, Salvation Army and Nursing Homes. We discussed how to approach the facilities, how not to, HIPPA Laws, and points/people to contact (via the Treatment Workbook). We have a lot of work to do! Peter, the Area 14 Treatment Committee and I are ready and eager to get to work. We hope to have good news of our progress for you at the April Assembly. We will also be setting up a Conference Call for our Committee in the near future to aid us in having regular communication between the District Treatment Committees between Assemblies. This Committee is on fire and we are setting very obtainable goals, 3 at a time and taking them from a-z, then setting three more. We are trying to instill this approach in the Districts of Area 14 as well. We look forward to any GSC Agenda Items we may be receiving from our Delegate Joyce in late February and eager to get to work on them. Site and Agenda: Richard C. – I would like to thank Kathy C. for taking notes. We looked at the 2019 and 2020 bid packet. Updating the packet was found needed to cover our current needs. Discussion on the need for help and ways this could be done too get more bids. If you want to help please email me and I will send you a copy of the bid packet. We had a discussion on the status of the bid packets that are currently out to hotels. We will have a motion coming out of committee under new business. I asked Meriem M. District 13 to be my Alternate and she agreed to be. Thank you for allowing me to serve.

Website: Steven N. – Nine of the ten Committee Assigned DCM's were present. They included David H. of District 7B, Evan S. of District 12B, Pati C. of District 14, Richard F. of District 22, Richard F. of District 22, DCM Diane S. of District 24 (also alt DCM Amy W.), Richard W. of District 31, and Jeffery W. of District 32. District 19A was not present. There were also seven visitors.

1. The group first reviewed the North Florida Area Conference Website Guidelines each receiving a hard copy. The guidelines are on the website also.
 2. The group reviewed the Webmaster Service Agreement and discussed it resulting in two motions:
 - a. It was moved seconded and passed unanimously to increase webmaster stipend from \$50 per month to \$100 per month. That motion was sent to the Finance Committee where it passed unanimously. The committee thanks past chair William F. for attending finance and presenting background information to that committee.
 - b. After the home page the ten most visited pages were Spanish Steps, Spanish Traditions, Assembly Agenda, Meeting Info, Spanish Responsibility Statement, Spanish Serenity Prayer, Spanish Unity Statement, Documents, and the Map of Area. It is interesting to note that of the 38,846 page views 78.67% were of the Spanish Mirror of the site. 79.14% of the visitors to our site were new with 20.86% being returning visitors.

Summary of Conference Procedures

Generally speaking, the General Service Conference follows *Robert's Rules of Order*, and proceeds on as informal a basis as possible consistent with the rights of all concerned. It is important to remember that the purpose of rules of order is to make it easier for the Conference to conduct its business; rules exist to allow the Conference to do what it needs to do to carry out the will of the Fellowship by reaching an informed group conscience. Over the years the Conference has adopted some exceptions to *Robert's Rules*, which help it to proceed more closely in accord with the spirit of A.A. Tradition.

Conference Quorum

A Conference quorum — two-thirds of all registered members — is required to conduct Conference business.

Committee System

To the extent possible, important matters to come before the Conference will be handled via the "Committee system." This assures that a large number of questions can be dealt with during Conference week. Each Committee considers carefully the items before it and presents its recommendations to the Conference as a whole for acceptance or rejection. Recommendations of Conference committees are automatically motions that have been made and seconded. Members are urged to resist the temptation to edit recommendations on the floor.

Substantial Unanimity

All matters of policy (Conference Advisory Actions) require substantial unanimity, that is, a *two-thirds majority*. Any actions, including amendments, that affect an Advisory Action, or motions that might result in such an action, also require a *two-thirds majority*. Because the number of members present in the hall during the week of Conference varies from time to time, the phrase "two-thirds majority" is taken to mean two-thirds vote of the Conference members voting, as long as the total vote constitutes a Conference quorum.

Minority Opinion

After each vote on a matter of policy, the side which did not prevail will always be given an opportunity to speak to their position. If the motion passes with two-thirds vote, the minority may speak. If the motion receives a majority vote, but fails to pass for lack of a two-thirds vote, the majority may speak.

Remember that saving "minority opinions" for after the vote, when there is no rebuttal, is a time-waster, for it can force the Conference body to reconsider a question that might well have been decided the first time around if it had been thoroughly examined from all sides.

General Rules of Debate and Voting

(Agreed to at the beginning of each Conference)

- People who wish to speak line up at the microphones and are called on in order.
- Each person may speak for two (2) minutes.
- No one may speak for a second time on a topic until all who wish to have spoken for the first time.
- Full discussion of a recommendation should take place *before* each vote.
- Everyone is entitled to, and should, express his or her opinion. However, if your perspective has already been stated by someone else, it is not necessary to go to the mike and say it again.

- Premature actions (e.g., amending motions early in the discussion or hastily calling the question) can divert attention from the subject at hand, thus confusing and/or delaying Conference business.
- Voting is by show of hands.

Tabling a Motion

Tabling a motion (postponing discussion to a later time during the same Conference):

- Must be made without comment.
- Requires a second.
- Is not debatable.
- Needs only a *simple majority* to pass.

Calling the Question

Calling the question brings debate to a halt while Conference members decide whether to proceed directly to a vote (the question) or go on with the debate. A motion to call the question:

- Must be made in order at the microphone.
- Must be made without comment.
- Requires a second.
- Is not debatable.
- Requires a *two-thirds vote*.

Reconsideration

A motion to reconsider a vote may be made only by a member who voted with the prevailing side, but it can be seconded by anyone.

- Only a *simple majority* is required.
- If the majority votes to reconsider, *full debate*, pro and con, is resumed. (Conference members are urged to limit discussion to *new* considerations of the question under debate.)
- No action may be reconsidered twice.

Floor Actions

Floor actions may be introduced at any time during the Conference except at the Sharing Sessions, and:

- Must be made without comment.
- Must be submitted in writing by the maker to the Conference secretary.
- Will come up for deliberation after all Committee reports have been heard.
- Require a *two-thirds majority*.

When a floor action is to be heard, its maker will be given two (2) minutes to state the rationale behind the action, after which the chair shall ask if there is a motion that the Conference decline to consider the floor action. A motion to decline to hear a floor action:

- Must be made without comment.
- Requires a second
- Is not debatable.
- Requires a *two-thirds majority*.

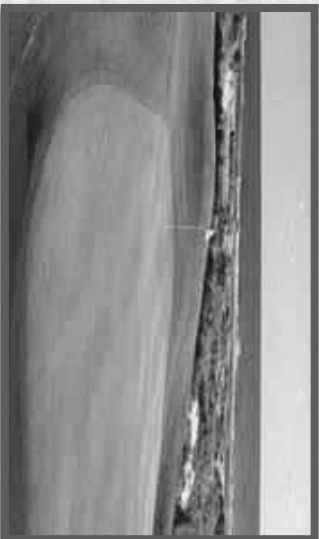
